

## FACILITATION OF THE 2022 FROZEN SEMEN IMPORT FOR MEMBERS

### ACE GROUP INC Conditions:

1. The buyer acknowledges that they have conducted their own research on the specifics of the stallion they are choosing to purchase frozen semen of and agree to make no claims to the ACE Group if the wrong selection is made.
2. Once the shipment arrives in Australia, the ACE Group will contact buyers with instructions on how to collect their purchase.
3. Shipment of the buyer's semen once arrived into Australia is at the buyers' expense. It will be stored at Gene Movers, Bacchus Marsh, Victoria.
4. Except for the farms Boeckmann Pferde and Klosterhof Medingen, the ACE Group places no pregnancy conditions on each dose of semen. If the buyer chooses to split doses, they can do so at their own risk and if two pregnancies are achieved within the one dose, then two Service Certificates can be issued by the ACE Group provided written confirmation is supplied via the use of ACE AI RECORD FORM.
5. Note - All **Klosterhof Medingen** and **Boeckmann Pferde** Stallions hold the special condition that only one pregnancy is allowed per dose. Doses may not be split, and doses are not permitted to be on sold to any other person. By ordering their semen you are acknowledging and accepting these conditions.
6. Payment of the full semen order must be made prior to or on 14<sup>th</sup> July 2022. Any orders not paid in full at this date will be cancelled.
7. The ACE Group has taken all necessary steps to ensure semen is of good quality and disease free but does not give any guarantees that pregnancies will be achieved. ACE Group does not make any guarantees as to the fertility and viability of the semen.
8. The ACE Group retains the right of refusal to any orders, and to cancel any orders they cannot fulfil due to any changes that are made, such as cost and availability that are outside of their control. All orders are final once submitted and paid for by the purchaser. See condition 3 in relation to shipment of the semen once it arrives in Australia.
9. Import and related fees of \$350 are included in the total price of the semen.
10. NO LIVE FOAL GUARANTEE ON ANY FROZEN SEMEN

### Stallions: Kjento, Glamourdale, Negro and Lantanas:-

- 1 dose – 1 certificate, 1 full dose will be used for one mare
- With Embryo transfer where more than 1 embryo is produced from 1 dose, the first embryo is included in the per dose fee. Each additional embryo – a charge of 50% of the per dose fee is required.
- ICSI is not allowed unless the ICSI contract is signed by the agent and the veterinarian who will perform the procedure.
- A breeder/buyer of a dose of semen cannot on sell the semen unless the agent is notified and it must always be a full dose.

### Semen Purchased from Stallions at KLOSTERHOF MEDINGEN and BOECKMANN PFERDE:-

Semen purchased from Klosterhof Medingen is strictly one insemination for this price, one pregnancy permitted. No pregnancy guarantee. No semen is to be sold/given to anyone else to achieve a pregnancy.

To apply for a Service Certificate from ACE Group, you must supply a completed (by your vet or AI Technician) Artificial Insemination Record Form (AI Form), downloadable from the website. Email the AI Form to [office@acegroupinc.com.au](mailto:office@acegroupinc.com.au) and a Service Certificate will be posted to you.

### Certification by Purchaser

I hereby make this order of frozen semen with the ACE Group in good faith and have read and understand the terms and conditions as stated above. I acknowledge that the ACE Group will take all necessary precautions to ensure all semen has been collected for import to Australia and that it meets with the Australian import legislation and that all paperwork will be completed by the ACE Group.

That the shipment will be fully insured until it safely arrives into Australia. From the date it has cleared Australian customs and is ready for shipment to me, it is considered to be stored at my risk and I will make the necessary arrangements to have it shipped to me within 21 days of it clearing customs in Australia, otherwise further storage charges may be payable by me.
